# WELFARE OF EX-SERVICEMEN, SERVING DEFENCE PERSONNEL AND THEIR FAMILIES BY THE GUJARAT STATE

### BENEFITS & ASSISTANCE GIVEN TO ESM, THEIR FAMILIES AND DEPENDANTS BY RAJYA SAINIK BOARD GUJARAT

- 1. In the last few years, the Gujarat Rajya Sainik Board has liberalized standards of welfare schemes for ex-servicemen / widows and their families. The welfare schemes for ESM and Widows are generally drawn up by the respective States for old & infirm ESM/widows who may be in penury and may not be having any source of lively hood. Whereas, the welfare schemes of Gujarat aim at enhancing socio-economic standard of the ex-servicemen / widows of Gujarat. Under this Scheme, until the sons of Widows / ESM attain age of 25 years, the widows and ESM are being supported by paying Rs 3000/- and Rs. 2000/- per month respectively, provided their income is not more than Rs 7000/- per month (i.e. Rs 84,000/- per annum).
- 2. Some of the schemes are as part of gratitude or good gesture from the Rajya Sainik Board Gujarat towards their veterans. These schemes include marriage grant of Rs 40,000/- for two daughters of widows and marriage grant of Rs 30,000/- for two daughters of ESM, paid to them without any income criteria.
- 3. The widows of soldiers who die while in Service, irrespective of their causes of death, are given House grant of Rs 50,000/- without any income criteria. The details of benefits / assistance extended to ESM/widows and their families from the Rajya Sainik Board are given as per Appendix A attached.

## BENEFITS & ASSISTANCE GIVEN TO ESM, THEIR FAMILIES AND DEPENDANTS BY GOVERNMENT OF GUJARAT

- 4. Besides the existing reservation for ESM in Class-III and Class-IV posts of 10% and 20% respectively, the Government of Gujarat has recently granted reservation of 1% seats for ESM for appointments in Class-I (Group A) and Class-II (Group B) posts being filled up by the State Public Service Commission.
- 5. In addition, to facilitate recruitment of ESM in police department, the Government has also granted relaxation in physical test during recruitment in police department as per norms laid down for Physical Proficiency Test (PPT) by the Army for higher age group.
- 6. More over, the reservation of 1% seats for wards of ex-servicemen and serving personnel which was only available in engineering courses, has also been extended in the entire higher educational courses like MBA, MCA etc.

7. Gujarat being a border state, due importance has been accorded towards the general welfare of ESM. The details of various Benefits and Assistance extended to ex-servicemen / widows and their families by the Govt. of Gujarat are given as per Appendix B attached.

# EX-GRATIA GRANT FROM HON'BLE CM'S JAWAN RELIEF FUND & PACKAGE OF ASSISTANCE FOR FAMILIES OF PERSONNEL KILLED IN KARGIL AND OTHER WAR AND OPERATIONS.

8. The care taken in looking after Families of Personnel Killed in War / Military Operations in particular and the welfare of ex-servicemen / widows and their families in general has direct bearing not only on the morale of serving personnel but the concerned shown by the Government towards the general welfare of ESM has positive effect in motivating the youth to join the Armed Forces. The details of Ex-Gratia Grant from Hon'ble CM's Jawan Relief Fund & Package of Assistance for Families of Personnel Killed in Kargil and other War and operations are given as per Appendix C attached.

### MECHANISM OF REDRESSAL OF GRIEVANCES.

9. To resolve the problems of Serving defence personnel and their families pertaining to their native villages regarding their property disputes, land and other issues causing harassment to them, the Gujarat Govt. has taken pro-active measures by nominating District Collectors as nodal officers to redress these problems urgently and sympathetically. The State Govt. has further advised all the Collectors and District Development Officers to give prompt attention to these problems faced by the serving soldiers and also have asked them to take steps to decide such issues expeditiously. The Addl. Chief Secretary (Home) has instructed all the District Collectors to form monitoring committees at the District level under them. The details of measures initiated by the State Govt. are given as per Appendix D attached.

### GUJARAT STATE SAINIK WELFARE WEB SITE.

10. The Gujarat State also has official Web site of Sainik Welfare Directorate, which makes information available at the fingertips of serving & veteran defence personnel of Army, Navy and Air Force & their families. On visiting the web site, the serving and veteran defence personnel from Gujarat would get details of all the Benefits and Assistance available from the Gujarat State, Gujarat Rajya Sainik Board and Kendriya Sainik Board along with sample application forms and check list for the documents required to be attached with these applications. The relevant Notifications & circulars are also uploaded on the website. All serving ranks from Gujarat may therefore be advised to visit this web site. #### EX-SERVICEMEN SAMMELANS / RALLIES

- 11. In comparison to ESM residing in bigger cities, the ESM residing in smaller towns and remote areas away from Military Stations / Sainik Welfare Offices need more attention. The focus for conduct of such rallies has therefore been kept on the ESM fraternity residing in smaller towns/ remote areas. Accordingly, besides the web site, to reach out to the ESM fraternity and to facilitate dissemination of information and educate the ESM on their various entitlements including pension, each District Sainik Welfare office has been conducting a Rally / ESM Sammlelan once in a year on a regular basis in their respective areas of jurisdiction. Since the adoption of this practice, during last three years, nearly 10000 of ESM & their family members were successfully contacted by reaching out to them at different places in the State, namely at Himatnagar, Dahod, Porbandar, Rajkot, Mehsana, Nadiad, Jamnagar, Bhavnagar, Dhandhuka, Borsad, Valsad, Junagadh, Rajpipala, Chhotaudepur, Patan and Amreli.
- 12. Besides the above periodical rallies, ESM Sammelan was also conducted in the month of July 2010 along with the inauguration function of Gaurav Senani Kumar Bhavan (Boys Hostel) held at Ahmedabad.
- 13. <u>Work Shop on Right to Information.</u> To educate the ESM fraternity on Right to Information and encourage them to use this Act to resolve their grievances, a works shop was organised at Vadodara, where in selected ESM representatives from all the districts participated. The work shop was conducted under aegis of Director General of Sardar Patel Institute of Public Administration, Gujarat State.

#### SAINIK GUEST HOUSES/ ARAM GRUHS

- 14. The foundation stone of the Gaurav Senani Bhavan (GSB) was laid at Ahmedabad by Hon'ble Chief Minister Shri Narendra Modi on 28 Mar 2008. The building was constructed by MES. It was inaugurated by Her Excellency the Governor of Gujarat Dr. Shrimati Kamla on 28 Feb 2010. In a very short time after its inauguration, the Bhavan has become popular amongst its users. The brief on GSB is given at Appendix E attached.
- 15. Besides the GSB at Ahmedabad, there are two more Sainik Aram Gruhs located at Rajkot and Vadodara as under:
  - (a) Sainik Rest house at Rajkot provides accommodation for 8 PBOR.
  - (b) Sainik Rest house at Vadodara provides accommodation for 7 PBOR.

#### BOYS HOSTELS AT VADODARA AND AHMEDABAD.

16. The hostel at Vadodara has capacity for 20 Students and the hostel at Ahmedabad has capacity for 30 students. These hostels provide free accommodation and subsidized messing to the Students. The Order of Priority for

admission is, Priority-I for Sons of Ex-Servicemen domiciled of Gujarat and priority –II is for Sons of Serving Soldiers who may have been posted out from local Stations. The photographs of recently constructed Boys Hostel at Ahmedabad are given below:

#### **NEW WELFARE INITIATIVE.**

17. During the 34<sup>th</sup> Meeting of Managing Committee of Rajya Sainik Board held at Rajbhavan, Gandhinagar on 28 Oct 2010, the construction of multipurpose Welfare complex encompassing Sainik Guest house, CSD Canteen Counter and administrative Block for District Sainik Welfare office at Surat has been sanctioned. The above complex would come up on 4000 Sq Mtr of land allotted to Rajya sainik Board Gujarat by the State Government at free of the Cost for Exservicemen fraternity of the South Gujarat. The ECHS polyclinic will also be constructed in the same complex by Regional Centre ECHS, HQ Southern Command, Pune.

For appointment to any reserved vacancies in Class III posts, a matriculate Exservicemen, who had put in not less than 15 years service in the Armed Forces, may be considered eligible for appointment to the posts for which the essential educational qualification is graduation and work experience of technical or professional nature is not essential. Exemption from Examination Fees

#### Grant of land for Agricultural

• Those serving Soldiers Native from Gujarat and who are about to retire within two years / Ex-servicemen (Up to the Rank of Colonel) having completed permissible length of service in Armed forces and have not resigned or taken premature retirement from service, having income (excluding pension) not more than Rs 9000/- per annum and undertakes only to do farming for their livelihood can be granted land maximum up to 16 Acres. #### Tenacity of Agricultural Land

#### Grant of Status of Farmer to ESM for the purpose of buying Agricultural land

- Gujarat Government has granted exemption of Value Added Tax (VAT) tax on sales of goods by Canteen Stores Department and Unit run Canteen to the categorized personnel who are entitled to the canteen facilities under regulations of Canteen Stores Department. #### Concession in allotment of Industrial shed/Plot & Establishment of SSI Units

Vide Home Department Resolution, *No. CMJ.102000 / 1872 / F, dated 29 Aug 2000*, war or operational martyrs and disabled Soldiers are paid Ex-Gratia grant from Hon'ble Chief Minister's Jawan Relief Fund as per following details:

- The families of Soldiers who die during Military Operations are given assistance as under (Married cases):-
  - Widow of the deceased soldier is paid:
    - Rs 50,000/- Cash
  - Monthly assistance of Rs1000/- per month, till she is alive or gets remarried.
  - Children of the deceased soldier are paid:
    - Monthly assistance of Rs 500/- for each child, maximum Rs 1000/- per month for two children till they attain the age of 25 Years.
  - Parents of the deceased soldier are paid
    - Monthly assistance of Rs500/- for each parent, maximum Rs 1000/- per month is paid to parents till they are alive.
- The families of Soldiers who die during Military Operations are given assistance as under (Un-Married cases):-
  - Mother of the deceased soldier is paid:
    - Rs 50,000/- Cash
  - Parents of the deceased soldier are paid
    - Monthly assistance of Rs500/- for each parent, maximum Rs 1000/- per month is paid to parents till they are alive.
- The disabled solder with 50% or more disability is paid as under:-
  - Rs 50,000/- Cash
  - Monthly assistance of Rs1000/- per month, till he is alive.

### PACKAGE OF ASSISTANCE FOR FAMILIES OF PERSONNEL KILLED IN KARGIL AND OTHER WAR AND OPERATIONS

#### KARGIL OPERATION

#### • Ex- Gratia Grant (Death) :

Officers- Rs 7.0 Lakh, JCOs- Rs 6.0 Lakh and Jawans- Rs 5.0 Lakh

#### • Financial Assistance to Disabled Soldiers.

(a) With Disability more than 60 %.

(b) With Disability less than 60 %.

Rs 2000/- for each percentage of disability.

#### • Financial Assistance to Parents

In case where the ex-Gratia grant (Death) is paid to widow being next of the kin of the martyr, the Parents (father and mother) will be paid Rs 1000/- per month. In case the either father or mother of the martyr dies subsequently the monthly aid will continue be paid till remaining parent survives.

Rs 3.0 Lakh

#### • Educational Assistance

The children of martyr (All Ranks) granted Educational Scholarship for maximum of two children, not exceeding the amount Rs 2000/- per month. The scholarship will be continued till the children complete their education or attain the age of 27 years which ever is earlier.

#### • Exemption of Tuition Fees

The children of martyr (maximum of two children) (All Ranks) are reimbursed actual fees paid by them in the institutions/Schools where they are studying. The reimbursement of fees will continue till the children complete their education or attain the age of 27 years which ever is earlier.

#### • Financial Assistance for Construction of House

All ranks are granted financial assistance within the ceiling of Rs 2.0 Lakh for construction of new house/ renovation and addition-alteration to the existing house. The construction of new house/ renovation and addition—alteration to existing house will have to be under taken through state agency i.e. Gujarat Housing Board for Urban area and Gujarat Gram Gruh Nirman Board for rural area.

#### • Allotment of land for Agricultural Purpose OR State Govt. Job for NOK

Regardless of Financial status, the legal hairs of the martyr (All ranks) are eligible for allotment of agricultural land within the limit of 16 Acres. **OR** 

• Under the provision of General Administration Department of the State, one dependent family member of the martyr is eligible for **State Government job**.

#### • Construction of memorial for each Martyr.

The state Government constructs a memorial for martyr in his native place.

#### 1971 WAR AND OTHER MILITARY OPERATIONS TILL 1999(PRE-KARGIL)

• The Ex-Gratia Grant (Death) of Rs 2.00 Lakh has been paid to legal heir of all ranks those who died during 1971 operation and thereafter during various counter insurgency operations from 1971 till 1999.

## REDRESSAL OF GRIEVANCES OF SERVING DEFENCE PERSONNEL, EX-SERVICEMEN AND THEIR FAMILIES

#### MECHANISM OF REDRESSAL OF GRIEVANCES.

- 1. To resolve the problems of Serving defence personnel, Ex-Servicemen and their families the Gujarat Govt. has set up mechanism as under:-
  - (a) Nodal designated Officers were appointed to monitor Sainik Welfare activities at the State and District level vide Home Department General Resolution No MSK-102003 / C.S. GOI.II/F dated 25 Nov 2003 (Annex-I).
  - (b) The revenue Department have advised the district Collectors to take prompt action in mitigating the property and land disputes of soldiers and their families vide their Circular No. JMN/ 3906/1670/A dated 27 Sept 2006 (Annex-II).
  - (c) The Home dept. has instructed the District administration to institute Mechanism to monitor and review grievances redressal of Serving Soldiers vide their circular NO. MSK/ 102007/GOI-4/F dated 17 Feb 2007 (Annex-III).
  - (d) The Addl. Chief Secretary (Home) has instructed all the districts Collectors to form District level monitoring committees for redressal of grievances of Serving Soldiers and ex-servicemen and also advised them to hold quarterly meetings of Zilla Sainik Boards vide his DO letters No. MSK/102007/GOI-4 dated 11 July 2007 and No. MSK/102007/GOI-4/ZSB dated 11 July 2007 respectively. (Annex-IV & V).
  - (e) Based on above instructions and orders, all the district Collectors have constituted District level monitoring committees for review of grievances redressal of Serving Soldiers and ex-servicemen.

#### JURISDICTION OF DISTRICT SAINIK WELFARE OFFICES.

2. To progress welfare issues of serving soldiers, the details of District Sainik Welfare & Resettlement Offices and Revenue Districts under their jurisdiction are given at Annexure-VI, so as to facilitate Military Stations, Units and Establishments to approach the concerned District Sainik Welfare & Resettlement Offices in the Gujarat State.

It is observed that the Defence Service Personnel by the very nature of their duties, have little time at their disposal to attend to their family and other social obligations, whenever they visit their home towns on leave. Their families, by and large, are left to fend for themselves. Their families face various kinds of hardships and frequently need assistance from Rajya / Zila Sainik Boards Civil Administration for their safety / security and settlement of disputes. The standing committee on Defence in their 19th Report have emphasized the need to appoint designated officers by each state Government / Union Territory for expeditious redressal of the grievances of servicemen as well as ex-servicemen. Suitable instructions have already been issued in this regard vide circular dated 1.4.63 to all the collectors with a direction to pay attention to the problems of ex-servicemen and look after their welfare. However in view of the above suggestion, the District Collectors are hereby appointed as Nodal Designated Officers at the district level to monitor and oversee the functioning of the Zila Sainik Welfare Office for resolving various issues. Similarly, at the state level Principal Secretary, Home Department, Sachivalaya, Gandhinagar is hereby appointed as Designated Officer to monitor the progress of a various issues related to welfare of servicemen and exservicemen with feed back from various concerned departments in the State as well as from district level.

With reference to the above mentioned subject, I am to say that the District administration plays an important role in grievances redressal of the serving armed forces personnel who are posted at far flung places in difficult situation. Like any other person, a soldier also faces a number of problems relating to his family, particularly land disputes, harassment by criminal or anti social elements, etc. which require prompt response. Unfortunately, they get limited leave and have hardly any time to get around different Government officers to pursue their cases. In such a situation, quick action by the Collector or the Supdt. of Police concerned would help in sorting out the matter and this would instill a great amount of confidence in the minds of these soldiers who are otherwise worried about the welfare of their families.

- 2. You are, therefore, requested to be proactive in the matters relating to serving soldiers and give prompt response to their problems.
- 3. You are also requested to set up an institution/mechanism to monitor and review the pending cases of defence personnel and their families. The officers entrusted with this responsibility be made accountable for pursuing the cases in a time bound manner. You may also review disposal of such cases at periodic interval with concerned officers. These steps will play a positive role in boosting the morale of the forces.



## SAINIK WELFARE ORGANISATION& JURISDICTION OF DISTRICT SAINIK WELFARE OFFICES.

The welfare of the Ex-servicemen and their dependents is the joint responsibility of the Centre and the State Governments. However, the majority of the problems have to be resolved only by the district administration and State Government. To assist the State Governments in this regard, the Department / Directorate of Sainik Welfare & Resettlement functions at the State level. The Directorate of Sainik Welfare exercise general control and supervision over the District Sainik Welfare Offices which cover more than two-three revenue Districts. Like the Kendriya Sainik Board at the Centre, the Directorate of Sainik Welfare is responsible for policy formulation and implementation of resettlement and welfare schemes for Ex-servicemen, widows and their dependents of the State.

# ACCOMODATION FOR RETD OFFRS, EX-SERVICEMEN, SERVING OFFRS & PBOR AT GAURAV SENANI BHAVAN, SHAHIBAUG-AIRPORT ROAD, AHMEDABAD-380 003

- 1. Sainik Guest House situated at Ahmedabad is known as Gaurav Senani Bhavan, which is located opposite to Camp Hanuman Bus Stop, near Branch Recruitment Office on Shahibaug-Air Port Road. Its central location makes it a convenient place to approach. The Bhavan is reasonably well equipped to make the occupants feel at home.
- 2. The foundation stone of the GSB was laid by the Hon'ble Chief Minister Shri Narendra Modi on 28 Mar 2008. The building was constructed by MES. It was inaugurated by Her Excellency the Governor of Gujarat Dr. Shrimati Kamla on 28 Feb 2010. In a very short time after its inauguration, the Bhavan has become popular amongst its users.
- 3. The Bhavan is located:
  - 2.2 K.M. from CSD Depot, Ahemdabad.
  - 2.4 K.M from ECHS Polyclinic, Ahemdabad.
  - 3.8 K.M. from Air Port
  - 5.2 K.M. from Railway Station
  - 7.4 K.M. from Central Bus Stand
- 4. The Bhavan is useful to the Veterans and their families who visit Ahmedabad for various reasons. The accommodations are also provided to Serving Officers & PBOR while on leave or on Temporary Duty.
- 5. The Gaurav Senani Bhavan is comprised of Ground plus two floors. It has nine double occupancy rooms, two three occupancy rooms and one five occupancy room with an additional facility of cottage for family of ESM under going medical treatment. It provides accommodation to 31 Guests.
